## A RESOLUTION

## **RESOLUTION SUMMARY**

PURPOSE: To address the current divide of our communities caused by hatred and bigotry. To acknowledge that the UCCS Student Government Association does not condone acts of violence and prejudice towards any communities. To support our students who are experiencing violence and hatred during an uncertain time. To advocate for UCCS Upper Administration and the CU Board of Regents, to acknowledge the impacts of new policies and administrative changes that impact the lives of students across the CU system. To advocate for the continual and ongoing inclusive care and belonging.

#### WHEREAS;

The Student Government Association acknowledges that there is an uncertainty moving forward in this country caused by the current political climate that has deeply impacted our students who are a part of initiatives supported by DEI, part of marginalized groups, and who are the targets for excessive hatred and bigotry through policies, media publishments, and the actions of different members of the public.

#### WHEREAS;

Since the federal transition on January 21, 2025, there have been a series of inconsistent and legally questionable orders that may end up harming students, and appear to be designed to stir up fear, hatred, and bigotry, while devaluing education. (See appendix

Further, many affirming orders from previous administration were revoked and these protected the rights of our students' identities, freedoms, families, the ability for them to get jobs, and their access to health care while surviving as a student. These collective actions invoke mass hatred and division, with sexist, racist, homophobic, transphobic, and dehumanizing rhetoric about each community that is impacted by the new federal administrations.

#### WHEREAS;

The Student Government Association affirms the Core Values set forth by UCCS which are Student Focus, Integration, Innovation, Collaboration, Inclusive Diversity, Dynamic Responsible Growth, Integrity. Furthermore, we affirm with the explanation of Inclusive Diversity which reads "We value inclusive diversity as a foundation for teaching and scholarship that prepares students, faculty, staff, and community members for both local and global multicultural realities. We provide an open, safe, and supportive campus environment based on mutual respect, engagement, and learning for everyone including those from the full spectrum of backgrounds, social identities, abilities, cultures, perspectives, and university roles."

#### WHEREAS;

The Student Government Association acknowledges the impacts the retraction of DEI program initiatives has had on the university, especially as it leaves students in a time of vague uncertainty. The Student Government Association is advocating for the UCCS Leadership and the CU Board of Regents to make clear how the retraction and implementation of policies by the new administration is impacting students on a system-wide level. Additionally, we ask that our preexisting values and policies be reaffirmed to show support for students through the reiteration of our stance.

#### BE IT RESOLVED;

- 1. The Student Government Association affirms the difficulty in navigating a federal transition of this nature in which we reaffirm our care for our administration, faculty, staff, and students.
- 2. The Student Government Association affirms with the UCCS Faculty Assembly in affirming its resolution Rw: Faculty Assembly Executive Committee, Notice of Motion Regarding the Federal Transition March 2025.

# THEREFORE BE IT HEREBY ENACTED BY THE UNIVERSITY OF COLORADO COLORADO SPRINGS LEGISLATIVE COUNCIL SENATE ASSEMBLED THAT:

Section 1: We, as a Student Government Association, acknowledge the Faculty Assembly Executive Committee and their RESOLUTION, and affirm with them.

Section 2: We, the Student Government Association, recognize and acknowledge the impact that changes in federal policies related to DEI have been insensitive, dehumanizing, unreasonable, and do not center our students' lived experiences. The Student Government Association will continue to establish and advocate for the wellbeing and safety of our students.

Section 3: The Student Government Association of UCCS, encourages our CU System to acknowledge the impact this has had on our students, staff, and faculty, and advocate for the establishment and continuation of policies that protect our students.

Section 3: We, as a Student Government Association, call on the Board of Regents of the Colorado University System to use their elected powers to acknowledge and advocate for our CU Established Regent Laws, including:

I. Regent Policy 10A – No individual or group shall be marginalized or systemically excluded.

II. Regent Article 1 - "freedom of expression embodied in the First Amendment to the United States Constitution and Article II, Section 10 of Colorado's State Constitution"

III. Regent Article 7 - rights of students to "free inquiry and discourse" in "their course discussions, course assignments, and scholarly work,"

IV. Regent Article 8 - commitment for all members of the campus community to not face discrimination "on the basis of race, color, national origin, sex, pregnancy, age, disability,

creed, religion, sexual orientation, gender identity, gender expression, veteran status, marital status, political affiliation, or political philosophy in admission and access to, and treatment and employment in, its educational programs and activities."
